# Regularly Scheduled Session of Mayor & Council Tuesday, October 15, 2013, 6:30 p.m. Phillip L. Pittore Justice Center, 25 South Union Street, Lambertville MINUTES

Mayor DelVecchio called the meeting to order at 6:31 p.m. with a statement of compliance with the open public meeting act, with the required notice given on Friday, October 11, 2013 to the Beacon, the Democrat, the Times, posting the agenda to the bulletin board at city hall, the website at <a href="www.lambertvillenj.org">www.lambertvillenj.org</a>, and noticing various people on the list serve, inclusive of department heads, city attorney and city engineer.

WHEREAS, the City of Lambertville last codified the general ordinances in 2002 and the land use ordinances are in need of codification, and

WHEREAS, in accordance with N.J.S.A. 40:49-4, the governing body may provide, from time to time, for the revision and codification of its ordinances, and

WHEREAS, in accordance with NJSA 40A:11-5 (x), a formal bid process for the printing of municipal ordinances or other services necessarily incurred in connection with the revision and codification of municipal ordinances is an exception, and

WHEREAS, the City received two quotes for the codification of ordinances from the following:

Coded Systems, Spring Lake Heights, NJ, total: \$18,050 (General Ordinances: \$8,970.00, Land Use Ordinances: \$8,530.00, Code on the internet: \$550.00)

Municode, Tallahassee, Florida: estimated total: \$47,685 (General Ordinances \$18 per page x 1,999 (2002 ordinance book) pages = \$35,982 plus Land Use Ordinances (estimate of 551 pages x \$18 per page = \$9,918 estimate), plus \$1,000 on-site conference, Graphics, tabular matter \$10 per page, Code on the internet, \$700 Electronic Delivery handling fee per delivery, \$75.

WHEREAS, the Certified Municipal Finance Officer has certified the funds are available which will be paid for by Ordinance Number 21-2013, a special emergency as permitted under N.J.S.A. 40A-55.1.

NOW THEREFORE BE IT RESOLVED by the Mayor and Council of the City of Lambertville, in the County of Hunterdon, in the State of New Jersey, that Coded Systems of Spring Lake Heights, New Jersey is hereby awarded the contract to codify the City's general and zoning/land use ordinances in an amount not to exceed \$18,050.

### **RESOLUTION NUMBER 145-213**

A Resolution to Award the Contract with Top Line Construction Corp in the Amount of \$422,739.93 for North Union Street Phase III Reconstruction

WHEREAS, the City of Lambertville is the recipient of a grant from the State of New Jersey, Department of Transportation in the amount of \$155,000, and

WHEREAS, the City of Lambertville adopted Bond Ordinance Number 14-2013 in the amount of \$500,000 to fund the reconstruction of North Union Street beginning at York Street and ending at Delaware Avenue, and

WHEREAS, on September 27, 2013, the City opened and read aloud the bid received from Top Line Construction Corp. of Somerville, New Jersey, in the amount of \$422,739.93, and

WHEREAS, the City Attorney has reviewed the bid packet and has found that the bid is responsive and responsible, and

WHEREAS, the City Engineer has reviewed the bid packet and recommends the City reject the bid received as it is in excess of the funds available to complete the project.

NOW THEREFORE BE IT RESOLVED by the Mayor and Council of the City of Lambertville, in the County of Hunterdon, in the State of New Jersey, that the bid received from Top Line Construction Corp of Somerville, New Jersey in the amount of \$422,739.93 is here by approved.

ADOPTED: October 15, 2013

Mayor DelVecchio explained that this resolution is to award the bid for Phase III of the North Union Street Project. He explained that the City Engineer recommends that we reject the bids as the amount exceeds the current budget. He asked for a motion in the affirmative to award the bid for the North Union Street Phase III Project. Council President Stegman made a motion to approve Resolution 145-2013. Councilwoman Warner seconded the motion. An opposing vote was taken, rejecting the motion by all members present. MOTION DEFEATED.

City Hall – a new automatic generator is in the process of being installed. This requires a new gas main and work will begin on that in approximately one week. The second and third project involves the paving of York Street which will be bid once United Water (new water main) and Elizabethtown Gas (gas main for new generator) are finished with their projects.

Police Station – no update.

### Construction Projects.

South Franklin & Weeden Street Drainage Project: The City Engineer and City Attorney are having discussions about closing out the project.

North Union Street Phase III the bid received was rejected tonight. The project will be

rebid in January.

York Street the grant application to NJDOT was filed by the City's Engineer to fund the reconstruction of York Street from North Franklin to Route 179, inclusive of Washington Street and York Street Extension.

Cottage Hill – this will be bid with North Union Street Phase III.

Update on projects for flood relief:

Swan Creek – Mayor DelVecchio informed the members of the public present that the application to FEMA to fund the Swan Street Flood Gates was submitted by the City Engineer. We received notice from the City Engineer that the project was approved by the State to be forwarded to FEMA for the approval process. Caren Franzini was present and asked if the City knew what our grant was ranked. Mayor DelVecchio responded that we would look into it. Ms. Franzini asked if there was something more residents could do. Mayor DelVecchio said they could write their legislators and ask for support.

The configuration with remain the same as with South Hunterdon Regional High School's board of education; five representing Lambertville, three representing West Amwell Township and one representing Stockton Borough. The board of educations in existence today will remain until June 30, 2014 or until the Commissioner of Education feels they are no longer needed.
