

# City of Lambertville Special Session of Mayor & Council Wednesday, March 20, 2013, 6:30 p.m. Phillip L. Pittore Justice Center 25 South Union Street, Lambertville

The meeting was called to order at 6:30 p.m. with a statement of compliance with the open public meeting act, providing the required notice on Friday, March 15, 2013 to the Beacon, the Democrat, the Times, posting the agenda to the bulletin board at city hall, the website at <a href="https://www.lambertvillenj.org">www.lambertvillenj.org</a>, and noticing various people on the list serve, inclusive of department heads, city attorney and city engineer.

# ROLL CALL.

# ORDINANCES - INTRODUCTION AND FIRST READING.

Ordinance Number 06-2013: An Ordinance to Establish a CAP Ordinance.

Mayor DelVecchio informed the members of the public present that if a municipality shall limit any increase in said budget to five percent (5%) or the index rate, whichever is less, over the previous year's final appropriations. The municipality may, in any year in which the index rate is less than five percent (5%), increase its final appropriations by a percentage rate greater than the index rate but not to exceed five percent (5%). These funds are banked in a "CAP" ordinance.

City of Lambertville Ordinance Number 06-2013 CALENDAR YEAR 2013 - TO ESTABLISH A CAP BANK (N.J.S.A. 40A: 4-45.14)

**WHEREAS**, the Local Government Cap Law, N.J.S. 40A: 4-45.1 et seq., provides that in the preparation of its annual budget, a municipality shall limit any increase in said budget up to 2.0% unless authorized by ordinance to increase it to 3.5% over the previous year's final appropriations, and,

**WHEREAS,** N.J.S.A. 40A: 4-45.15a provides that a municipality may, by ordinance, bank the difference between its final budget appropriations and the 3.5% increase authorized by this ordinance when said difference is not appropriated as part of the final budget; and,

**WHEREAS**, the Mayor and Council of the City of Lambertville in the County of Hunterdon hereby determines that this difference in the amount of \$50,376.60 that is not appropriated as part of the final budget shall be retained as an exception to the final appropriations in either of the next two succeeding years.

**NOW THEREFORE BE IT ORDAINED,** that any that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years; and,

**BE IT FURTHER ORDAINED**, that a certified copy of this ordinance as introduced be filed with the Director of the Division of Local Government Services within 5 days of introduction; and,

**BE IT FURTHER ORDAINED**, that a certified copy of this ordinance upon adoption, with the recorded vote included thereon, be filed with said Director within 5 days after such adoption.

INTRODUCED: March 20, 2013

ADOPTED: April 23, 2013

Council President Stegman made a motion to adopt the Ordinance to Establish a CAP Bank. Councilman Sanders seconded the motion. An affirmative roll call vote was taken in favor of the motion by all members present. MOTION CARRIED.

#### RESOLUTIONS.

Resolution to Introduce the 2013 Budget.

Mayor DelVecchio introduced the 2013 budget which was read by title into the record. He informed the members present that the assessed value of the homes in the City of Lambertville are down approximately 3 million dollars or about .5%; the average home value is: \$353,681; the average tax bill is up approximately \$12 per year or \$1 per month; the levy is up 1.6%; surplus is down \$15,000 or 6.6% but we are left with almost \$300,000 after appropriations; this budget includes a 2% raise for all personnel with no reduction in the work force; includes a savings in the budget of \$10,000 due to the recycling program; \$2,500 in fuel due to the change at City Hall from oil to gas; \$5,900 in electric fees due to the third party purchasing agreement; the City paid down debt in the amount of \$777,000 which is the most ever in one year; saved \$51,643 from FEMA and we were able to cancel our emergencies from Hurricane Irene; and the reserve for uncollected is up \$5,000 which is 1.54%.

NOW THEREFORE BE IT RESOLVED by Mayor and Council of the City of Lambertville, in the County of Hunterdon, in the State of New Jersey, that the 2013 Calendar Year is hereby introduced with a motion made by Council President Stegman and seconded by Councilwoman Warner.

RESOLUTION NUMBER 64-2013: A Resolution to Reject the Bids for the Pay for your Meter with Your Cell Phones, Dated: September 20, 2012.
