STATEMENT OF COMPLIANCE.

Mayor DelVecchio opened the meeting at 7 p.m. and read a statement of compliance with the open public meeting act. The meeting notice was emailed on Monday, May 5, 2014 to the Beacon, the Democrat, the Times; the agenda was posted to the bulletin board at city hall, the website at www.lambertvillenj.org; and notice was emailed to various people on the list serve, inclusive of department heads, city attorney and city engineer.

RESOLUTION TO GO INTO CLOSED SESSION TO DISCUSS CONTRACTS, PERSONNEL, ACQUISITION OF PROPERTY AND POTENTIAL LAW SUITS.

Mayor and Council did not go into closed session.

PLEDGE OF ALLEGIANCE.

Mayor DelVecchio led the public in the Pledge of Allegiance.

MOMENT OF SILENCE.

Mrs. Ege led the public in a moment of silence in honor of those serving in the United States Armed Forces.

PROCLAMATIONS.

Mayor DelVecchio informed the members of the public present that both the Union Fire Company Number 1 and the Fleet Wing Fire Company Number 3 are celebrating their 150th anniversary. He will attend a dinner scheduled for tomorrow evening and present the following proclamations:

UNION FIRE HOUSE NUMBER 1 - CELEBRATING 150 YEARS.

Proclamation

WHEREAS, the first record of a fire fighting organization in this area dates back to June 21, 1822 with the creation of the "Delaware," a joint fire department between Lambertville and New Hope, *and*

WHEREAS, the Globe Fire Company of Lambertville established in 1847 was reorganized on July 18, 1864 as the "Union Fire Company Number 1" at the time of the Civil War with membership of the Union Army, *and*

WHERAS, Council gave approval to the membership for the use of the Globe and the Fire House on Coryell Street, *and*

WHEREAS, the first equipment purchase was a new hose carriage which cost \$600 in 1865 which was quickly followed up with a new purchase in 1869 of the Button Steamer purchased for \$4,500, *and*

WHEREAS, Old Nell, the Ahrens-Fox pumper was retired from duty on Sunday, April 23, 1961 and was placed in the Ernest N. Day Museum at Dunellen, New Jersey. The Union Fire Company Number 1 solicited for her return to the City of Lambertville and she is currently housed and on display at 230 North Main Street, *and*

WHEREAS, the Union Fire Company Number 1 was first located on Coryell Street in 1869, moved to Church Street in December of 1884, and then relocated to their current place at 230 North Main Street, *and*

WHEREAS, early membership included John B. Jones, Dr. Lilly, A.C. Barber, Joseph Werts, R. McDowell, Charles Skillman, Gervas Ely, John B. Creed, Charles Schulhaus, Gershon Akers, John L. Coryell, George Arnett, John E. Masten, Nelson Oblinger, Walter H. Williamson, Edwin Lawyer, A.T. Coleman, A.K. Yos, Jr., James Strouse, Charles Heins, Francis J. Siwy, Sr., Leon Brady, Harry D. Blair, Robert J. Hayes, Sr., James R. Ege, *and*

WHEREAS, while the membership has changed throughout the years, the motto "In Union there is Strength" continues with the following membership: Ron Siwy – President, Robert Hayes – Vice President, Jeff Dey – Secretary, James Bellamy – Assistant Secretary, Nate Waldron – Treasurer, Butch Godown, and member Don Huggins.

NOW THEREFORE BE IT RESOLVED by the Mayor and City Council of the City of Lambertville, in the County of Hunterdon, in the State of New Jersey that the Union Fire Company Number 1 is hereby congratulated on 150 years of serving the community.

FLEET WING FIRE HOUSE NUMBER 3- CELEBRATING 150 YEARS.

WHEREAS, the Fleet Wing Hook & Ladder Company Number 3 was organized in August of 1864 by C.H.W. Van Sciver, a local painter who proclaimed they were "one of the brightest stars in the cluster of the fire-fighting associations in our city," *and*

WHEREAS, the first meeting was held on August 23, 1864 in the Union League Rooms on Bridge Street with seventy-seven members in attendance where the constitution and bylaws were written, and incorporated on March 27, 1867, *and*

WHEREAS, the first firehouse was located in a building owned by the Belvidere Delaware Railroad Company and was located below the Lambertville Station Restaurant, and they moved to 12 North Main Street on January 6, 1866, and again relocated to their current located at 230 North Main Street in the City, and

WHEREAS, the 1989 Membership includes: Richard N. Sheetz – President, Kenneth F. Bacorn – Vice President & 1st Lieutenant, Frank L. Kramer, Jr. – Secretary, Gary C. WHEREAS, while the membership has changed throughout the years, the motto "Fearless, Active, And True" lives on with the following current list of Administrative Officers: Richard B. Roy, Jr. – President, Roy D. Myers, Jr. – Vice President, Frank L. Kramer, Jr. – Secretary, Richard B. Roy, Sr. – Treasurer.

NOW THEREFORE BE IT RESOLVED by the Mayor and City Council of the City of Lambertville, in the County of Hunterdon, in the State of New Jersey that the Fleet Wing Hook & Ladder Company #3 is hereby congratulated on 150 years of serving the community.

BE IT FURTHER RESOVLED that Friday, May 9, 2014 is hereby proclaimed as the 150th Anniversary Day for the Union Fire Company Number 1 and the Fleet Wing Fire Company Number 3 day in the City of Lambertville.

Ordinance Number 11-2014: A Capital Ordinance to Purchase Meters for Ferry Street in the amount of \$10,000.

Mayor DelVecchio read the ordinance into the record by title. He informed the members of the public present that this ordinance will authorize the spending of funds from the General Capital Fund Balance to fund the purchase of additional digital meters, parts, batteries and supplies needed to enforce the parking meters.

Ordinance Number 11-2014

An Ordinance Appropriating \$5,000 from the General Capital Fund Balance for the Purchase Additional Meters, Parts and Supplies

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LAMBERTVILLE, IN THE COUNTY OF HUNTERDON, NEW JERSEY AS FOLLOWS:

Section 1. The sum of \$10,000 is hereby appropriated from the General Capital Fund Balance for the following capital purpose by the City of Lambertville, in the County of Hunterdon, in the State of New Jersey, including all work and materials necessary therefor and incidental thereto:

Purchase of Additional Digital Meters and Parts, including batteries.

Section 2. The capital budget of the City of Lambertville is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency herewith.

Section 3. This ordinance shall take effect as provided by the law.

Introduced: May 8, 2014

Mayor DelVecchio asked for a motion to introduce on first reading Ordinance Number 11-2014. Council President Stegman made the motion to introduce Ordinance Number 11-2014. Councilwoman Asaro seconded the motion. An affirmative roll call vote was taken in favor of the motion by all members present. MOTION CARRIED.

Public Hearing and Final Adoption: May 20, 2014

ORDINANCES - SECOND READING AND FINAL APPROVAL.

Ordinance Number 07-2014: CAP Bank Ordinance.

Mayor DelVecchio read the ordinance into the record by title. He informed the members of the public present that this ordinance is to establish a CAP Bank with the unused funds from the 2013 budget, allowing the city to bank the funds for use in the next two years budget cycle.

ORDINANCE NUMBER 07-2014

CALENDAR YEAR 2014 ORDINANCE TO ESTABLISH A CAP BANK (N.J.S.A. 40A:4-45.14)

WHEREAS, the Local Government Cap Law, N.J.S. 40A:4-45.1 et.seq., provides that in the preparation of its annual budget, a municipality shall limit any increase in said final budget appropriations to 0.50% unless authorized by ordinance to increase it to 3.5% over the previous years final appropriations; and.

WHEREAS, a municipality may, by ordinance, bank the difference between its final budget appropriations and the 3.5% increase authorized by this ordinance when said difference is not appropriated as part of the final budget; and,

WHEREAS, the City Council of the City of Lambertville City, County of Hunterdon, hereby determines that this difference in the amount of \$102,524.19 that is not appropriated as part of the final budget shall be retained as an exception to the final appropriations in either of the next two succeeding years.

NOW THEREFORE BE IT ORDAINED, that any amount authorized herein above that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years; and,

BE IT FURTHER ORDAINED, that a certified copy of this ordinance as introduced be filed with the Director of the Division of Local Government Services within 5 days of introduction; and

BE IT FURTHER ORDAINED that a certified copy of this ordinance upon adoption, with the recorded vote included thereon, be filed with said Director within 5 days after such adoption.

FIRST READING AND INTRODUCTION: April 7, 2014 SECOND READING AND FINAL ADOPTION: May 8, 2014

Mayor DelVecchio opened the public hearing on Ordinance 07-2014 and asked if there were any questions or comments from the public.

There being no comments or questions, he asked for a motion to close the public hearing on Ordinance Number 07-2014. Councilman Sanders made a motion to close the public hearing on Ordinance Number 07-2014. Council President Stegman seconded the motion. An affirmative roll call vote was taken in favor of the motion by all members present. MOTION CARRIED.

Mayor DelVecchio asked for a motion to adopt on second reading and final approval, Ordinance Number 07-2014. Council President Stegman made a motion to adopt Ordinance Number 07-2014 on second reading and final approval. Councilman Sanders seconded the motion. An affirmative roll call vote was taken in favor of the motion by all members present. MOTION CARRIED.

PUBLIC HEARING ON THE 2014 PROPOSED BUDGET.

Mayor DelVecchio opened the public hearing on the 2014 budget and read the 2014 budget into the record. He made the following comments: He said that this budget represents 6.82% decrease in spending; however, the tax levy will increase by \$1 per month for the average home priced at \$350,875 in the City of Lambertville. The city downsized the police department by 1 patrolman, public works by 1 employee, ½ person in the clerk's office, ½ person in the Court and reduced the staffing in the Tax Collector's Office. Employees will receive a 2% raise across the board. This is the first full year with a part-time tax collector with an overall savings of \$10,000. In the police department, one full time officer is retiring in May. The City has implemented several programs to help save money and they include: electric procurement through third party purchasing, phone services were awarded through a bid, pays almost \$20,000 for snow removal overtime and equipment expenses, and went long term for 20 years on bonds with a 3.09% rate and \$87,000 premium.

Mayor DelVecchio asked for any questions or comments on the 2014 budget. There being no questions or comments, he asked for a motion to close the public hearing on the 2014 budget. Council President Stegman made the motion to close the public hearing on the 2014 budget. Councilman Sanders seconded the motion. An affirmative roll call vote was taken in favor of the motion by all members present. MOTION CARRIED.

BUDGET AMENDMENT.

Mayor DelVecchio explained that the 2014 proposed budget needed to be amended and certain line items were moved to accommodate the request of the DLGS.

WHEREAS, it is necessary to establish specific salary for specific positions;

WHEREAS, in order to attract and retain qualified employees there exists a need to adopt and implement a Deferred Compensation Plan for the employees of the City of Lambertville (hereinafter referred to as "Employer"), which will provide employees the opportunity to enhance their financial security at retirement through savings of compensation on a deferred basis as provided by Section 457 of the Internal Revenue Code of 1986, as amended ("Code"); and

WHEREAS, in 2014 the Employer adopted a Deferred Compensation Plan provided by AXA-Equitable and assigned the plan identifier (66-PD- Equibable-053107) City of Lambertville by the Division of Local Government Services; and is hereby adopted and signed by the employer,

WHEREAS, the offering of additional investments from another contractor will provide additional retirement investment options to participating employees; and

WHEREAS, there is no direct financial cost to the Employer to adopt and implement an additional employee deferred compensation plan and Service Agreement, and

WHEREAS, the Employer was contacted by Alexander Joice of AXA Equitable and asked for an opportunity to meet with City employees for the purpose of discussing Deferred Compensation Plans, and

WHEREAS, AXA Equitable solicited for proposals from ING, which included Prototypical Plans and Service Agreements that meet the requirements of the Municipal, County and Authority Deferred Compensation Programs Rule N.J.A.C. 5.37.

NOW, THEREFORE, BE IT RESOLVED, by Mayor and Council of the City of Lambertville, in the County of Hunterdon, in the State of New Jersey, that the Mayor and City Clerk are hereby authorized to execute the Service Agreement (bearing identifier: 88-SA-Equitable-080813 assigned by the New Jersey Division of Local Government Services) with AXA Equitable for the provision of administrative and investment services.

BE IT FURTHER RESOLVED that _Christie Ehret/Susan Bacorn_____ is hereby designated as the Local Plan Administrator for the administration of the Deferred Compensation Plan.

BE IT FURTHER RESOLVED that the City of Lambertville is adopting a deferred compensation plan substantially similar to one on which a favorable Private Letter Ruling has been previously obtained from the federal Internal Revenue Service except for provision added by reason of the Small Business Job Protection Act 1996 (United States Public Law no. 104-188), the Tax Payer Relief Act 2001(United States Public Law no. 105-34) and the Economic Growth and Tax Relief Reconciliation Act 2001 (United States Public Law no 107-16), and all such provisions are stated in the plan in terms substantially similar to the text of those provisions in the Internal Revenue code section 457. The use of the Ruling is for guidance only and acknowledges that for Internal Revenue Service purposes, the Ruling of another employer is not to be considered precedent.

BE IT FURTHER RESOLVED that a certified copy of this resolution and all necessary required documents shall be submitted to the Director of the Division of Local Government Services within the State Department of Community Affairs for approval.
