NORTH UNION STREET PARKING LOT:

8-23.4 Parking by Permit. In addition to the metered parking spaces, there shall be created a maximum of five (5) parking spaces which shall be available to businesses by permit only. The permits will be issued by the City Clerk on a first come first served

basis. Each spot shall be numbed to correspond with the permit number and available to the permit holder at all times.

8-23.5 Fees. The fee for the permit shall be forty-five (\$45) dollars per month with a late fee of five (\$5) dollars if not paid by the fifth (5th) of the month. If the fee is not paid by the tenth (10th) of the month, the permit shall be null and void and available for issuance to another business. A list will be maintained by the City Clerk to be utilized in the event of vacancy.
