STATEMENT OF COMPLIANCE.

Mayor DelVecchio asked Mr. Richard to join him at the dais. He thanked Eric for his dedication to the citizens of the City of Lambertville. Council members took turns reading the proclamation into the record.



WHEREAS, Eric Richard was appointed to the board of the Lambertville Municipal Utilities Authority on February 1, 2011; *and*

WHEREAS, Eric served as Chairman from 2011 to 2015, contributing significantly to numerous projects that maintained to and improved the quality of life of the residents of the City of Lambertville; *and*

WHEREAS, Mr. Richard worked tirelessly on the budget with a focus on maintaining the delivery of vital services in a cost-effective manner, and championed efforts to reduce resident complaints, and helped lead implementation of the Authority's Odor Action Plan; *and*

WHEREAS, Mr. Richard resigned from his position on the Lambertville Municipal Utilities Authority on February 3, 2015, to move with his family to the Township of West Amwell, *and*

NOW THEREFORE BE IT RESOLVED by the Mayor and Council of the City of Lambertville, in the County of Hunterdon, in the State of New Jersey, that Eric Richard is hereby honored and thanked for his many contributions to the City of Lambertville, including his tenure on the board of the Lambertville Municipal Utilities Authority.

WHEREAS, DeAnna's began on Lilly Street in a small 30-seat restaurant, but grew in acclaim and popularity to necessitate the need for expansion, leading to its current location on North Franklin Street, in the process maintaining one of the City's historic buildings as a place for friends to join together, and

WHEREAS, DeAnna's, "the hippest restaurant, in the oldest bar, in the smallest city, in the USA," has created their own "Manhattan-in-Lambertville" destination which has brought countless visitors to our community to eat in the beautiful outside courtyard, the intimate dining rooms, and the historic bar, and

WHEREAS, Diana Paterra continues to create culinary magic in the kitchen while her partner, Lisa Nichols, maintains the restaurant's beautiful decor and coordinates the front of the house, while still finding time to create numerous delicious desserts; both contributing to DeAnna's warm, friendly environment, and

WHEREAS, Diana Paterra and Lisa Nichols have honored and embraced the long and colorful history of their building at 54 North Franklin Street, a brick and stucco building built in 1863 which had been the home of Mason's Bar, a working-class establishment once featured in Weird New Jersey Magazine, and

from which they have kept the original bar stools, neon bar sign, glass block windows, and the wainscoting around the bar, and which had also served as a canning factory, a temporary Catholic Church, and is even rumored to have been home of bootleg business run by a one-armed Italian!

WHEREAS, the governing body of the City of Lambertville strives to save tax dollars, assure clean air and water, improve working and living environments, and build a community that is sustainable economically, environmentally, and socially; and

WHEREAS, the governing body of the City of Lambertville wishes to build a model of government which benefits its residents with green community initiatives which are environmentally and economically sound, easy to replicate, and affordable to implement; and

WHEREAS, in an attempt to focus on green issues, the Mayor and City Council of the City of Lambertville wishes to re-establish a Green Team;

NOW, THEREFORE, BE IT ORDAINED by the Mayor and City Council of the City of Lambertville, in the County of Hunterdon, in the State of New Jersey, that the Green Team will be comprised of the following membership which will be nominated by the Mayor and confirmed by Council:

- 1. Full membership of the Environmental Commission;
- 2. One member of the Recreation Commission;
- 3. One member of the Shade Tree Commission:
- 4. One member from the public;
- 5. City Employees (city clerk, public works director)

BE IT FURTHER RESOLVED that the purpose of the Green Team is to:

- facilitate the successful completion of the requirements for re-certification of Sustainable Jersey:
- educate and encourage all city employees, residents, and businesses to participate in green initiatives;
- collaborate with public and private green committees to ensure the replication of best practices and to ensure a coordinated effort within the City of Lambertville;

Resolution Number 60-2015: A Resolution Opposing New Jersey Assembly Bill Number 4197 and any other efforts made by the Senate or Assembly to reduce funding for historic preservation.

RESOLUTION #60-2015

A Resolution Strongly Opposing New Jersey Assembly Bill NO. 4197 and Any Other Efforts Made by the Senator or Assembly to Reduce Funding for Historic Preservation

WHEREAS, the City of Lambertville takes great pride in its historic character and its interest and efforts in preserving its historical assets. Settled in 1705, the City of Lambertville is one of the oldest communities in Hunterdon County. Originally established as a transit point across the Delaware River, it grew into an industrial center from the development of the Raritan Canal. In preparation for important battles of the Revolutionary War, Washington and his army crossed the Delaware River at what is now Lambertville and marched onto critical battles during the Revolution; and

WHEREAS, Lambertville flourished during the Industrial Revolution leaving a legacy of historic pre-Victorian and Victorian buildings and homes; and

WHEREAS, the historic resources of Lambertville and so many other municipalities have been an important cultural element in making New Jersey an attractive place to live, work and visit; and

WHEREAS, historic tourism has been an economic driver for all of New Jersey and certainly for the City of Lambertville; and

WHEREAS, efforts to preserve important elements of New Jersey's history have been fueled to a large degree by the New Jersey Historic Trust and its critical support for important historic elements; and

WHEREAS, the funding from the New Jersey Historic Trust has funded numerous sites in Lambertville, including the A. H. Holcombe House, also known as Lambertville City Hall, by providing \$486,180 in grants that have allowed this historic Victorian home to be partially restored in a way that combines historic preservation, functionality and good government; and

WHEREAS, funds from the New Jersey Historic Trust have also been used for the upgrade of Lambertville's Centenary United Methodist Church, a Romanesque-style church designed a Trenton architect in 1865 and the James Wilson Marshall House, a pre-Victorian home to the discoverer of gold in California in 1848; and

WHEREAS, the New Jersey Historic Trust has also assisted numerous historic buildings and properties in Hunterdon County, including Bethlehem Township Old Town Hall, the Case-Dvoor Farmstead in Raritan Township, the Christoffel Vought Farmstead in Clinton Township, the historic Hunterdon County Courthouse (which received grants of over a million dollars for renovation of the famous site of the Lindbergh trial), the Hunt's Mill and M.C. Mulligan & Sons Quarry in the Town of Clinton, the Kirkpatrick Memorial Presbyterian Church in East Amwell, and the Locktown Stone Church in Delaware Township, among numerous other historic sites listed on the website of the New Jersey Historic Trust; and

WHEREAS, the New Jersey Historic Trust has also helped hundreds of historical sites throughout the State of New Jersey in every or just about every county, which are listed in the website of the New Jersey Historic Trust; and

WHEREAS, on November 4, 2014, New Jersey voters approved, by a 65% to 35% margin, Public Question Number 2, a legislatively-referred constitutional amendment, which was designed to dedicate 6 percent of corporate business tax revenues to open space, farmland and historic preservation.

WHEREAS, the ability of the New Jersey Historic Trust to continue to fund historic projects is now threatened by New Jersey Assembly Bill No. 4197, from the 216th Legislature; and

WHEREAS, under the old formula used to allocate funds raised by bond issues for the Garden State Preservation Fund, six percent was earmarked for historic preservation and grants and the operation of the New Jersey Historic Trust (which administers grants made to non-profit and public entities for historic preservation); and

WHEREAS, under New Jersey Assembly Bill No. 4197, the percentage of money allocated to the New Jersey Historic Trust for grants and operation will be reduced by approximately 50 percent; and

WHEREAS, this change in funding will drastically reduce the amount of money available to preserve New Jersey's important historic heritage; and

WHEREAS, cutting funding for historic preservation will do irreparable damage to the culture, history and tourism opportunities for the State of New Jersey, which will have a significant impact on tourism and the numerous jobs and economic benefits resulting this multi-billion dollar economic driver in this State.

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Council of the City of Lambertville, County of Hunterdon, New Jersey, that it strongly opposes New Jersey Assembly Bill No. 4197 and any other efforts made by the Senate or the Assembly to reduce funding for historic preservation.

BE IT FURTHER RESOLVED, that the Mayor and Council urge members of the New Jersey Assembly and Senate to reject this effort to frustrate the will of the voters who overwhelmingly voted in 2014 to support open space and historic preservation.

BE IT FURTHER RESOLVED, that the Clerk of the City of Lambertville is directed to send a copy of this Resolution to the following:

- 1. The Governor of the State of New Jersey.

WHEREAS, the Township of West Amwell passed an ordinance dated September 9, 2013 (Ordinance No. 12, 2013) authorizing the formation of a Government Energy Aggregation in the Township of West Amwell, New Jersey, and authorizing the City of Lambertville to act as the Lead Agency for the program named the South Hunterdon Renewable Energy Cooperative Community Energy Aggregation ("SHREC CEA") Program

WHEREAS, the City of Lambertville is acting as the Lead Agency of the SHREC CEA; and

WHEREAS, the residents of Lambertville and West Amwell are included in the SHREC CEA on an "opt-out" basis, as set forth in applicable rules (N.J.A.C. 14:4-6).

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the City of Lambertville, in the State of New Jersey that the Mayor and Clerk are hereby authorized to execute the documents required for the community aggregation of electric.

City of Lambertville Ordinance Number 07-2015

An Ordinance to Amend the Revised General Ordinance of the City of Lambertville, 1990, Chapter 7: Traffic: Create a Handicapped Parking Space at 11 Church Street

BE IT ORDAINED by the Mayor and Council of the City of Lambertville, County of Hunterdon, State of New Jersey, that the Revised General Ordinances of the City of Lambertville, 1990, Chapter 7: Traffic, be amended as follows:

SECTION 1: Section 7-4.7 Parking Restricted for Use by Handicapped Persons is amended by adding the following location:

Handicapped parking space in front of 11 Church Street.

SECTION 2: This ordinance shall take effect immediately upon adoption according to law.

This is a capital ordinance which will reduce surplus to \$650,000.

City of Lambertville ORDINANCE NUMBER 08-2015

AN ORDINANCE OF THE CITY OF LAMBERTVILLE, IN THE COUNTY OF HUNTERDON, NEW JERSEY, PROVIDING FOR THE REDESIGN OF THE CITY'S WEBSITE AND RELATED EXPENSES AND THE ACQUISITION OF CERTAIN EQUIPMENT AND ITEMS IN AND FOR THE CITY AND APPROPRIATING \$59,300 TO FUND THE SAME.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LAMBERTVILLE, IN THE COUNTY OF HUNTERDON, NEW JERSEY (not less than two-thirds of all members thereof affirmatively concurring) AS FOLLOWS:

Section 1. For the purpose of the re-design of the City's website and related equipment and expenses, and including expenses incurred in the planning, design and bidding thereof, there is hereby appropriated the sum of \$25,000 from the City's Capital Account.

 $\underline{\text{Section 2}}$. Section 2. For the following purposes, there is hereby appropriated the aggregate sum of \$34,300:

- a. Filing Cabinets for Construction Office in the sum of \$1,800.00;
- b. Filing Cabinets for the Tax Office in the sum of \$1,200.00;
- c. Carpeting for the Construction & Finance Office in the sum of \$4,000.00;
- d. Design and Installation of the Welcome Sign in the amount of \$3,000.00;
- e. Change of Zone, Zoning Ordinances in the amount of \$5,800.00;
- f. Review of Codification of Ordinances in the amount of \$3,500.00; and
- g. Street Scape in the amount of \$15,000.00

Section 3. The capital budget or temporary capital budget (as applicable) of the City is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency herewith. In the event of any such inconsistency and amendment, the resolution in the form promulgated by the Local Finance Board showing full detail of the amended capital budget or amended temporary capital budget (as applicable) and capital program as approved by the Director of the Division of Local Government Services is on file with the Clerk and is available there for public inspection.

Section 4. This ordinance shall take effect as provided by law.

Mayor DelVecchio informed the members of the public present that this ordinance will be the topic of further discussion at the April 1st planning board meeting.

Ordinance Number 05-2015: An Ordinance to Amend Chapter Five, Licensing, For Taxicabs, Establishing a Complaint Procedure and Requiring Training for Drivers.

Mayor Delvecchio read the ordinance into the record by title. He informed the members of the public present that this ordinance will formalize a complaint procedure.

City of Lambertville ORDINANCE NUMBER 05-2015

An Ordinance to Amend Chapter V, General Licensing, Taxicabs; Establishing a Complaint Procedure, the Contract Compliance Review Board

The City of Lambertville, in accordance with the State of New Jersey, NJSA 48, is licensing all autobuses, liveries, limousines and taxicabs in accordance with the State of New Jersey Statutes, 48:16, 2C:24, 2C:39, 2C: 35, 2A:168A. Therefore, it is a requirement in the City of Lambertville for all autobuses, liveries, limousines and taxicabs to be registered and licensed and to comply fully with the requirements of the State of New Jersey and the City of Lambertville.

I. AUTO CAB, TAXICAB,

<u>Definition as defined in N.J.S.A. 48:16-1</u>, shall mean and include automobile or motor car, commonly called taxi, auto cab, omnibus, or by whatever name or designation they may now or hereafter be known or designated as "taxicab", engaging in the business of carrying passengers for hire, which is held out, announced or advertised to operator run, or which is operated to run over any of the streets or highways of the City, and particularly accepts and discharges such persons as may off themselves for transportation from points or places within the City, or which is hired by charter, or for a particular contract, or by the day or hour or other fixed period, or to transport passengers to a specified place or places, or which charges a fare or price agreed upon, in advance, between the operator and the passenger. Nothing in this section contained shall be construed to include any motor vehicle by whatever name or designation used and employed solely in transporting school children or teachers, or auto buses which are subject to the jurisdiction of the Board of Public Utility Commissioners, or any motor vehicle owned or operated by the City of Lambertville, County of Hunterdon, State of New Jersey, or operated by any nonprofit organization in the business of transporting persons not for profit.

- b. <u>License Required; Fees for License</u>, as defined in N.J.S.A. 48:16-2, necessity of municipal consent before operating auto cab; limited on license fee. No auto cab shall be operated along any street in any municipality until the owner thereof shall obtain the consent of the elective governing body or member thereof having control of the public streets in the municipality. The City of Lambertville, in accordance with P.L. 2011, c. 135, licenses will be the subject of a public auction for the license.
- c. <u>Issuance of License, Inspection of Taxicabs</u>, In accordance with P.L. 2011, Chapter 135, a municipality shall publish a notice in the newspaper circulating generally within the municipality state the number of new or additional licenses to be authorized and the application period for the new or additional licenses. The notice shall specify a time and date after which no further applications will be accepted. The notice shall be published at least twice and at least one week apart, with the second notice published at least 30 days prior to the time and date specified in the notice as the time and date after which no further applications will be accepted.

The Mayor's designee shall have the power to issue or refuse to issue a license, in pursuance of the terms of this section. The number of licenses shall not exceed 4, one license per vehicle.

Any license hereafter issued may be transferred upon the payment of a transfer fee of fifty (\$50) dollars for each and every such transfer, and subject to the provisions of subsection 5-1.5, upon obtaining approval, in writing, of the Mayor's designee.

- d. <u>Application Information</u>: shall include the name, address, phone number of the owner and each operator, copies of insurance, State of New Jersey Business Registration, Sales Tax Certificate, Fingerprinting results and any other information as deemed necessary by the Police Department and/or the City Clerk.
- e. Requirements for Applications: No license to operate a taxicab shall be granted to any person unless he is a citizen of the United States, or shall have declared his intention to become such a citizen. In the case of a co-partnership, no license shall be granted to operate a taxicab unless such corporation is either incorporated or is duly authorized to do business under the laws of this State. All applicants and prospective taxicab drivers must:

i. Prior to the issuance of a license:

- 1. submit to criminal history checks (fingerprinting) at a designated Live Scan facility;
- 2. have reached his or her 21st birthday;
- 3. not have had a license revoked in any other state; and
- 4. possess a currently valid, State of New Jersey issued driver's license.
- f. Fingerprinting: No license shall be granted to operate a taxicab to any person, or to any partnership or corporation who is not, or the members of or officer of which are not persons of good moral character, or who has, or if any of the members of the partnership, or officers of the corporation have been convicted of any following crimes: aggravated assault, arson, burglary, escape, extortion, homicide, kidnapping, robbery, aggravated sexual assault, sexual assault or endangering the welfare of a child pursuant to N.J.S.A. 2C:24-4, whether or not armed with or having in his possession any weapon enumerated in subsection r. of N.J.S.A. 2C:39-9, or other than a disorderly persons or petty disorderly persons offense for the unlawful use, possession or sale of a controlled dangerous substance as defined in N.J.S.A. 2c:35-2. In any other state, territory, commonwealth, or other jurisdiction of the United States, or any country in the world, as a result of a

conviction in a court of competent jurisdiction, a crime which in that other jurisdiction or country is comparable to one of the crimes enumerated in paragraph one (1) of the subjection. If a person who has been convicted of one of the crimes outlined in this ordinance or in P.L. 2011, c.135 (A1471 3R), and can produce a certificate of rehabilitation issued pursuant to N.J.S.A. 2A:168A-8 or if the criminal offense occurred outside New Jersey, an equivalent certificate from the jurisdiction where the criminal offense occurred, the criminal offense shall not disqualify the applicant from operating or driving an auto cab and/or taxicab.

g. <u>Issuance of License; Number Limited; Transfer Fee</u>: In accordance with P.L. 2011, Chapter 135, a municipality shall publish a notice in a newspaper circulating generally within the municipality stating the number of new or additional licenses to be authorized and the application period for the new or additional licenses. The notice shall specify a time and date after which no further applications will be accepted. The notice shall be published at least twice and at least one week apart, with the second notice published at least 30 days prior to the time and date specified in the notice as the time and date after which no applications will be accepted.

The Mayor's designee shall have the power to issue or refuse to issue a license, in pursuance of the terms of this section. The number of licenses shall not exceed four (4), one per vehicle, four (4) vehicles in total. Any license hereafter issued may be transferred upon the payment of a transfer fee of fifty (\$50) dollars for each and every such transfer, and subject to the provisions of subsection 5-1.5, upon obtaining the approval in writing of the Mayor's designee.

- h. Inspection Required Before Issuance of License: No Auto cab or Taxicab shall be licensed until it has been thoroughly and carefully inspected and examined by the Police Department and found to be in a thoroughly safe condition for the transportation of passengers. Such licensed taxicabs shall be clean, fit and of good appearance and well painted and varnished. Side curtains or shades shall not be permitted on any such licensed vehicles. The Department shall refuse a license to any applicant or, if already issued, revoke or suspend the license of any vehicle found to be unsafe for the transportation of passengers. All reports of such inspections and examinations, after having been submitted to the Mayor's designee shall be filed with the City Clerk and become a part of the application filed for the licensing of such vehicle, as hereinafter provided.
- i. <u>Contract Compliance Review Board</u>: The Contract Compliance Review Board shall consist of the Mayor or the Mayor's designee, the police director and one member of the local Chamber of Commerce. It is the responsibility of the Contract Compliance Review Board to take measures to ensure that all provisions of this ordinance have been met.
 - i. The first complaint or inspection by the police department when a taxicab company is found to be noncompliant will result in the immediate suspension of services of the taxicab service until the company can provide the proper documentation or address the area of concern to the satisfaction of the Contract Compliance Review Board;
 - ii. The second complaint or documented review where the company is found to be out of compliance or negligent, a hearing will be scheduled with the Contract Compliance Review Board. The Review Board will decide whether to suspend or terminate the license or to allow the company to continue provide services under the license.

- iii. In the event of a suspension or termination of a license, the City of Lambertville will not prorate the fee of a license.
- j. <u>Display Requirements</u>: Every licensed taxicab shall display prominently in the interior of the auto/taxicab and in a manner required or approved by the Mayor's designee, the following:
 - i. its City license number;
 - ii. a photo identification of the driver; and
 - iii. a contract compliance placard, provided by the City, which advises the public on how to submit a complaint to the Contract Compliance Review Board.
- k. Register to be Maintained: The City Clerk shall keep a register of the name of each person owning or operating vehicle or vehicles licensed under this section, together with the license number and the description, make dimension of such vehicles, with the date and complete record of inspections made of them. All applications for licenses shall be filed by the City Clerk and carefully preserved for reference. All licenses issued shall be recorded in books provided for that purpose, which shall be in such form as the Mayor's designee shall prescribe. All such records shall be open to the inspection of the public at all reasonable times and shall be deemed the official records of the Department and of the City.
- Inspection, Written Reports Required: The Police Department shall maintain a constant vigilance over all taxicabs to see that they are kept in a condition of safety for the transportation of passengers, and to this end shall have the right at any and all times to inspect any and all licensed vehicles, and shall maintain a record, in writing of a report of such inspections. All taxicabs found to be out of compliance with this ordinance will be given one warning. The second time they are found to not be in compliance with this ordinance will require an appearance before the Compliance Review Board.
- m. <u>Insurance</u>: as defined in N.J.S.A. 48:16-3, no such consent shall become effective until the owner of the auto cab shall have filed with the clerk of the municipality in which such operation is permitted, an insurance policy of a company duly licensed to transact business under the insurance laws of this State conditioned for the payment of business unless the applicant shall have complied with the provisions of Chapter 231 of the Laws of 1926, embodied in N.J.S.A. 48-16, et seq., N.J.S.A. 39:6B-1 and P.L. Chapter 135, Assembly number 1471 of the State of New Jersey, and the acts amendatory thereof or supplemental thereto, relating to the filing of an insurance policy covering the owner or operator of such vehicles for damages to person for which he may become liable by reason of the ownership, maintenance or use of the vehicle, not less than \$35,000 of motor vehicle liability insurance coverage, or the rate established and set by State of New Jersey Statutes. All such insurance policies shall be issued to cover the term of the license issued by the City.
- n. <u>Licenses Revoked or Suspended</u>; Licenses granted under the preceding sections may be revoked or suspended at any time after notice and hearing by the <u>Compliance Review Board</u> if the vehicle shall not be in a safe condition for the transportation of passengers or not kept in conformity with the terms of this <u>ordinance</u> or if used or its use permitted for any improper, immoral or illegal business or purpose, or for the violation of any statute or law of the State of New Jersey or of the United States, or for the violation of any of the provisions of this section, or any of the rules and regulations made by the Appropriate Authority.

- o. Mayor and Council to Designate Stand: The Mayor and Council are hereby authorized to designate such place or places within the Central Business District or Highway Commercial Zones of the City as public taxicab stands as the Mayor and Council, in its judgment, may deem necessary as may be required for the proper transportation of passengers. The City Clerk is hereby further authorized to grant permits for the operation of taxicabs from private premises as it may deem necessary and proper. No taxicab shall occupy any public taxicab stand unless such taxicab shall have been licensed as provided in this section.
- p. Regulations: No taxicab, while waiting for employment by passengers shall stand on any public street or space other than that at or upon a taxicab stand designated or established in accordance with this section, nor shall any driver of such taxicab seek employment by repeatedly and persistently driving his taxicab to and fro in egress from any theater, hall, hotel, public resort, railroad station or other place of public gathering, and no driver shall solicit passengers for a taxicab except when sitting upon the driver's seat thereof, nor shall any driver of a taxicab solicit employment in the transportation of passengers by driving in or through any public street or public place a slow rate of speed, commonly designating as "cruising."

Upon request, no owner or driver of a taxicab or other vehicle regulated under this article, unless previously engaged, shall refuse or neglect to carry an orderly person anywhere within the City of Lambertville. Upon request, every driver of a taxicab is required to provide each passenger with a receipt indicated the driver's name, fee and description of the trip

No person operating a taxicab shall permit or allow any person other than a passenger being transported for hire in or about such taxicab when in service as a taxicab.

- q. <u>Penalties for Violations:</u> The penalties for violation of this ordinance shall be as set forth in Chapter I, Section 1-45 of the Code of the City of Lambertville.
- r. The City of Lambertville retains the right to accept or reject applications for taxicab licenses for any reason. Fees will not be prorated or refunded should the applicant be found to be non-compliant.

All other previous ordinances pertained to Taxicabs are hereby repealed.

The Chamber requests road closures (North Union Street from Bridge to York Street and Church Street from Union to George Street), use of the North Union Street Parking Lot, City Services (Police and Public Works), and approval of the one day social affairs permit. Mayor DelVecchio commented that the Chamber will need to finalize their plans and meet with city officials to finalize the plans. He asked for a motion to approve the request of the Greater-Lambertville-New Hope Chamber of Commerce for the June 11th Food Truck Event. Council President Stegman made a motion to approve the request, inclusive of the one day social affairs permit, road closures, use of public works and police providing the Chamber reimbursed the city for all fees associated with this event. Councilwoman Warner seconded the motion. An affirmative roll call vote was taken in favor of the motion by all members present. MOTION CARRIED.

2015 NEW HOPE CELEBRATES PARADE is scheduled for Saturday May 16th with step off at 11:30 a.m. with pedestrians entering the parade from York Street and the floats entering from Delevan Street. The floats will use the Holcombe Jamison Farmstead near the Toll Bridge for the staging area. The committee is asking for Delevan Street to be closed for the floats from 11 am to 12 noon. The parade route will begin at York Street on North Union Street and march south towards Bridge Street. They will turn right onto Bridge Street and then cross the Lambertville-New Hope Free Bridge to New Hope.

The Clerk was asked to set up a meeting with Sharon Fronabarger of the New Hope Celebrates Committee. Mayor DelVecchio asked for a motion to approve the request from the 2015 New Hope Celebrates Parade Committee. Council President Stegman made a motion to approve the request as submitted. Councilman Sanders seconded the motion. An affirmative roll call vote was taken in favor of the motion by all members present. MOTION CARRIED.

NEW BUSINESS.

CHERRY & NORTH UNION STREET PARK PRESENTATION.

Brad Campbell representing the Environmental Commission was present to discuss the park and the plans.

Mayor DelVecchio informed the members of the public present that the North Union and Cherry Street park was the subject of an application for 8 housing units. After their first appearance before the Planning Board, it was reduced to 6 units. The neighborhood was in favor of preserving this as open space so the city held a referendum which was overwhelmingly supported by the voters. The Environmental Commission and the Recreation Commission worked together to have a design charrette which resulted in the final plan which is being presented tonight. He thanked those involved in the process and turned the meeting over to Brad Campbell, the Chairperson for the Environmental Commission.

Mr. Campbell presented a two sided copy to the members of council and gave a brief overview of the process followed. He started by thanking Lester Myers, the Acting Public Works Director and said he was a great partner with the Food Waste Recycling Program. Mr. Campbell said this was a wonderful process to examine different elements. They obtained an open space planning grant. They received support from Councilman Sanders, Council President Stegman, Mayor DelVecchio along with 40 plus members from the community at the first meeting and more attendees at the second meeting. Residents express vision thoughts and there was strong support for a dog park. After consideration, all recognized that this was not the highest and best use of the space. The property owners located by the park would like it to stay as is and others supported an active use element. The photo is the result of a public process. Residents voted for the elements they liked.

Scheme A is the preferred option by both the Environmental Commission and the Recreation Commission. Early on in the project the neighbors reported an issue with stormwater management. The rain gardens will address that issue. Mayor DelVecchio asked the clerk to investigate if the rain gardens would satisfy the city's issue with the DR Canal Commission from the South Franklin Street project.

The committee would like a hybrid of scheme A, adding the curve walk from scheme B into plan A.

Mr. Campbell asked Mayor and Council to approve the concept, spending capital funds on the park and to permit fundraising.

The committee is exploring options for the future which include a super glide rink but they have more homework to do. Mayor DelVecchio commented that less is more.

Council President Stegman asked Mr. Campbell to explain the garden rooms with benches. Mr. Campbell responded that they aren't actually rooms just outdoor spaces for people to gather. Council President Stegman asked about the proximity of the LMUA pumping station and if they thought about asking them for restrooms. Mr. Campbell stated that they were considering asking for help with screening the site and asking CVS to have the rear of the building painted with a mural.

Mayor DelVecchio asked who prepared the conceptual design. Mr. Campbell said Michael Chaney, Julia Taylor's husband, who is a landscape architect. Mr. Campbell further commented that he wanted to recognize the work of a number of local leaders; Julia Taylor, various local businesses like Rojo's for their contributions. He said it was a wonderful pulling together of resources.

Mayor DelVecchio asked for a motion to approve the conceptual plan and fundraiser for the North Union and Cherry Street Park. Council President Stegman made a motion and Councilwoman Warner seconded the motion. An affirmative roll call vote was taken in favor of the motion by all members present. MOTION CARRIED.

Mayor DelVecchio commended the Environmental Commission, the Recreation Commission, and Brad Campbell for the public process which was well advertised and well attended. He thanked Mr. Campbell.

FOOD WASTE COMMITTEE.

Mayor DelVecchio informed the members of the public present that the City wanted to grow the Food Waste Recycling Committee. He announced the responsibilities would be delegated to the Environmental Commission who would be charged with reviewing and analyzing the data, reporting back to the Mayor and making a recommendation on the best way to grow the program. Councilwoman Asaro asked to be appointed to the committee.

- 1. Review and analyze the pilot program;
- 2. Report all findings back to the Mayor and Council;
- 3. Make recommendation on the best way to expand/grow the program.

BE IT FURTHER RESOLVED that the Environmental Commission will report back to Mayor. ADOPTED: March 17, 2015

Mayor DelVecchio asked for a motion to approve Resolution Number 57-2015. Council President Stegman made a motion to approve the resolution. Councilwoman Asaro seconded the motion. An affirmative roll call vote was taken in favor of the motion by all members present. MOTION CARRIED.

PARKING COMMITTEE TO STUDY PARKING SOLUTIONS ON THE SOUTHERN END OF THE CITY.

Mayor DelVecchio informed the members of the public present of the formation of a Parking Committee to study parking solutions in the southern end of the city adjacent to the railroad and DRC. He announced that Brad Campbell will chair the committee. The committee will be charged with analyzing the cost of the project, the return on investment, environmental impact, etc.

A Resolution to Establish A Parking Committee to Study Parking Solutions At the Southern End of the City WHEREAS, the members of the governing body of the City of Lambertville wish to establish a Parking Committee to study parking solutions at the southern end of the City; and

WHEREAS, the Mayor has nominated the following people to serve on the Committee: Brad Campbell as the Chairperson, Edward Padilla, Daniel Whitaker, Executive Director of the Greater Lambertville-New Hope Chamber of Commerce - David Morgan, Vice-President of the Greater Lambertville-New Hope Chamber - Glenn Davis, Executive Director of the LMUA - Thomas Horn Council President Stegman, Councilwoman Warner; Doug Gravier; and

WHEREAS, the committee will be charged with the following:

- The process to use in leasing or acquiring the property,
- The number of parking spaces,
- The best design of the parking lot,
- Meters verses Kiosks for customer payments,
- Funding the project

NOW THEREFORE BE IT RESOLVED by the Mayor and Council of the City of Lambertville, in the County of Hunterdon, in the State of New Jersey that the Parking Committee is hereby established to study the parking situation at the southern end of the city.

ADOPTED: March 17, 2015

Caren Franzini asked if there would be representation from the Chamber on the Committee. Mayor DelVecchio responded that both David Morgan – executive director and Glenn David – vice president are representatives of the Chamber. He informed the members of the public present that many years ago Caren Franzini was the Executive Director of the EDA she introduced him to a parking expert from Chicago. They spoke of a parking deck and it was quickly determined that it would not be an option for Lambertville.

Ms. Franzini asked if the committee would be looking at parking in other locations. Brad Campbell responded that they would be looking to see where they might be able to pick up added spaces.

Council President Stegman said this was a great idea for the community. He previously sat on a committee with Ed Padilla. In his opinion, it will need to be advertised well to encourage the community to use it.

Mayor DelVecchio commented that initially they discussed a "loop" but it is not feasible for cars to cross the canal. They will need to enter and exit through the same manner. A pedestrian crossing is feasible.

Brad Campbell encouraged the public to visit SPLASH which is an excursion on the river.

Richard Park of New Hope, PA, a member of the Swan Creek Rowing Club asked if this was the concept that was discussed in the Bucks County Herald which would increase parking by 400 spaces. Mayor DelVecchio responded by saying that it is not necessarily the case. The City has had a couple of initial discussions but there are issues with the railroad and state. Mr. Park stated that the Swan Creek Rowing Club has a defined lease for use of the property. Mayor DelVecchio asked for a copy of the lease and said it would be helpful to the committee.

Mayor DelVecchio asked for a motion to approve the resolution, confirming his appointments. Councilman Sanders made a motion to approve the resolution. Councilwoman Warner seconded the motion. An affirmative roll call vote was taken in favor of the motion by all members present. MOTION CARRIED.

BOARD APPOINTMENT.

Mayor DelVecchio nominated Rob Carmenini to the vacant position on the Recreation Commission. Councilman Sanders made a motion to confirm the Mayor's nomination. Councilwoman Warner seconded the motion. An affirmative roll call vote was taken in favor of the motion by all members present. MOTION CARRIED.

UPDATE ON VARIOUS CONSTRUCTION IMPROVEMENT PROJECTS.

<u>Cavallo Park</u>. The following applications have been filed: NJEDA (HDSRF PA/SI/RI funding), DRCC, DEP, SOIL CONSERVATION (HCSCD), SHPO. We are waiting on DEP and Soil

Conservation. The final application will be to Green Acres and they need to have the approval letters from all agencies, the site investigation reports and the City's ROSI.

<u>Library Roof</u> – bids were accepted on 02-26-14 publicly opened and read aloud at City Hall located at 18 York Street.

<u>Generator Projects</u>: the application was filed with SHPO. Once approved, the application with the DRCC will be filed. Then we can bid the project.

UPDATE ON PROJECTS FOR FLOOD RELIEF.

Swan Creek Flood Gates: The new grant has not been released as of this date. The City Engineer will participate in a webinar about funding options.

Caren Franzini informed the members of the public present that Dick Zimmer sent her information on a flood mitigation grant and loan program. He is interested in hearing from the City.

Mayor DelVecchio asked Caren Franzini to touch base with Zach from Senator Booker's office on the status of his request to the legislature.

Mayor DelVecchio asked the City Clerk to contact the city's representative from DEP to set up a meeting with Frank Scangarelli. Participants include the city engineer, and the committee members.

Mayor DelVecchio informed the members of the public present that Senator Booker's office has been very helpful.

Council President Stegman thanked him for the outreach efforts within the past year. He said he receiving information about outages, restorations, storm warnings and it has been a good experience.

The meeting adjourned at 8:05 p.m. with a motion made by Councilman Sanders and seconded by Councilwoman Warner. An affirmative voice vote was taken in favor of the motion by all members present. MOTION CARRIED.
