I was diagnosed with an auto-immune disease. As my condition progresses and my joints continue to deteriorate, simple everyday tasks have become more difficult or nearly impossible. One of the struggles I deal with is getting in and out of the car. I have to park in front of our house to be able to get in and out of the car due to the condition of my hip joints, the use of a forearm crutch, and the unique way I have to lift myself into the seat. I have not been able to park in our driveway in several years.

As we all know, space in Lambertville can be a little tight. To the right of the driveway is a drop off to the neighbor's property and to the left is the house. The space is just too small for me to open the door wide enough and lift myself into the seat. Although I am usually parked in front of our home there have been occasions when the space was not available. This poses more struggles for me since S. Franklin Street is so steep. It is very difficult for me to walk up or down the street.

Even though we do have a single car driveway, when I spoke with the NJ division of disabilities, they said there are always special circumstances. I am hoping you will consider this to be one of those times.

I really dislike letting people know I am sick or discussing my illness, so the fact that I will now be advertising it in front of our home is very difficult for me. However, I know this is the next step in keeping my independence.
