ORDINANCE NO. 21-2017

AN ORDINANCE OF THE CITY OF LAMBERTVILLE, IN THE COUNTY OF HUNTERDON, NEW JERSEY, PROVIDING FOR IMPROVEMENTS AND REPAIRS TO THE CITY'S PARKS AND APPROPRIATING \$65,000 TO FUND THE SAME.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LAMBERTVILLE, IN THE COUNTY OF HUNTERDON, NEW JERSEY (not less than two-thirds of all members thereof affirmatively concurring) AS FOLLOWS:

Section 1. For the purpose of improvements to City parks, including but not limited to the installation of upgrades required by the American with Disabilities Act to Eli Field, as detailed by an estimate on file in the Office of the City Clerk, and including all work and related materials necessary therefor or incidental thereto, there is hereby appropriated the sum of \$65,000, including the sum of \$43,584.47 available to the City from County of Hunterdon's Open Space Banked Funds, and the balance being appropriated from City accounts including funds available from a grant from Friends of Ely Park, and City's Open Space Reserve.

Section 2. The capital budget of the City is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency herewith. In the event of any such inconsistency and amendment, the resolution in the form promulgated by the Local Finance Board showing full detail of the amended capital budget or amended temporary capital budget (as applicable) and capital program as approved by the Director of the Division of Local Government Services is on file with the Clerk and is available there for public inspection.

<u>Section 3</u>. This ordinance shall take effect as provided by law.
