

**City of Lambertville**  
**ORDINANCE NO. 01-2019**

AN ORDINANCE OF THE CITY OF LAMBERTVILLE, IN  
THE COUNTY OF HUNTERDON, NEW JERSEY, PROVIDING  
FOR REPAIRS TO THE CITY'S HEAVY EQUIPMENT AND  
APPROPRIATING \$30,000 TO FUND THE SAME.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LAMBERTVILLE,  
IN THE COUNTY OF HUNTERDON, NEW JERSEY (not less than two-thirds of all members  
thereof affirmatively concurring) AS FOLLOWS:

Section 1. For the purpose of refurbishment and repair of Department of Public  
Work's heavy equipment and vehicles to extend useful life for additional 5+ years, and including  
all work and related materials necessary therefor or incidental thereto, there is hereby  
appropriated the sum of \$30,000 appropriated from City Capital Improvement Fund, available  
through the insurance reimbursement.

Section 2. The capital budget of the City is hereby amended to conform with the  
provisions of this ordinance to the extent of any inconsistency herewith. In the event of any such  
inconsistency and amendment, the resolution in the form promulgated by the Local Finance  
Board showing full detail of the amended capital budget or amended temporary capital budget  
(as applicable) and capital program as approved by the Director of the Division of Local  
Government Services is on file with the Clerk and is available there for public inspection.

Section 3. This ordinance shall take effect as provided by law.
