Updates:

- LEC to reach out the Shade Tree Commission to inquire if any help is needed regarding their sampling distribution efforts
- Lester Myers provided the LEC with an update regarding the composting program, shared thoughts regarding the placement of additional waste receptacles around the city and thoughts on the monitoring of unauthorized uses. Public Works is willing to work with the LEC regarding their potential river clean-up initiatives.
- Helen Pettit presented a 2015 Army Corps document to the LEC regarding potential plans that have been proposed for mitigating flooding in the northern areas of the city. Ms. Pettit wanted to bring to the LEC's attention that mailers regarding the project have been sent and that the project may be entering a more active phase. The LEC will inquire with other branches of the city to determine the status of the project.
