

#### MINUTES

#### WELCOME – John Woods, Chairperson

Mr. Woods read the statement of compliance into the record, noting that the annual notice was advertised in the February 6<sup>th</sup> issue of the Times, and the meeting schedule was provided to the Times, the Democrat; and the meeting agenda was posted on the City's website at <u>www.lambertvillenj.org</u> and on the bulletin board at City Hall. Mr. Woods welcomed the members of the public present and asked all to stand for the Pledge of Allegiance.

# PLEDGE OF ALLEGIANCE.

Mr. Woods led the public in the Pledge of Allegiance.

Mr. Woods asked the City Clerk to call the roll:

## MEETING MINUTES.

Mr. Woods asked for a motion to approve the **02-28** Meeting Minutes. Dan Seiter made a motion to approve the meeting minutes. Councilwoman Asaro seconded the motion. An affirmative voice vote was taken in favor of the motion by all members present. MOTION CARRIED.

## NEW BUSINESS.

Hate Crimes – Bruce Cocuzza, Police Director

Mr. Cocuzza passed out a copy of a letter and flyer issued by Christopher Porrino, the New Jersey Attorney General about acts of hatred and bias.

Other Councils.

Mr. Woods informed the members of the public present that board members accepted the responsibility of reaching out to other local Human Rights Councils to obtain some information on how they operate. He asked each person to give an overview.

#### PRINCETON HUMAN SERVICES COMMISSION - John Woods

Mr. Woods called the Princeton Human Rights Council. He spoke to Joanna Kay and Elisa Neira who is the Executive Director of Human Services Department. They have been a "Welcoming City" since 2015. They are not a Sanctuary City. There are some pluses and minuses but they feel they are better off as a "Welcoming City." Mr. Woods did some research on Welcoming City's. He found, like with Sanctuary City's the definition varies.

Council President Stegman asked if "Welcoming City's" were nationwide. Mr. Woods confirmed that they are and he said he would email everyone the information he found. Council President Stegman asked if he knew how many Welcoming City's there were and if he could obtain guidelines. Mr. Woods commented that he was informed by the Princeton HRC that they asked their immigrants for input and they did not want to proceed with becoming a Sanctuary City. Council President Stegman asked Mr. Woods to ask them if they would do the same thing today.

LOCAL GROUPS - Mayor DelVecchio

Mayor DelVecchio addressed the members of the board and the public present and stated that there was a meeting organized by Los Puentes of Fisherman's Mark with approximately 200 immigrants. The immigrants didn't ask for anything and would prefer the City not take any action. The Mayor has asked the Library to consider adopting a photo membership card for their membership to use. This would have a dual purpose and would be helpful to the Library but also provide a photo identification card to their membership.

The Mayor invited everyone to the April 4<sup>th</sup> event that the Mayor and Police Director will be participating in organized by Indivisible and Filomena Hengst and Sarah Gold. It is being held at the Phillip L. Pittore Justice Center from 6 -7 pm. The City Clerk will circulate information to the HRC members.

<u>NEW HOPE HUMAN RELATIONS COMMISSION</u> – Councilwoman Asaro

Councilwoman Asaro spoke with Dan Brooks and Vivian Francesco from the New Hope HRC. The purpose is to enforce the Borough's law that prohibits discrimination in employment, housing and places of public accommodation and promotes equal opportunity. They split the committee into two. They have an Advisory Board that deals with all kinds of discrimination and the Clerk and Police Chief handle all LGBTQ issues. They would like to meet with the City sometime in the future.

HUNTERDON COUNTY DIVORSITY COUNCIL- Bambi Kuhl

Mrs. Kuhl reported that she spoke with Kathy Zahn who serves on the Diversity Council for the County of Hunterdon. They also work with the members of Helpline, Legal Services, Catholic Charities, and Somerset County Court. Their mission is mostly to provide information. They did not mention LGBTQ during the conversation.

# OLD BUSINESS.

<u>APRIL 4<sup>TH</sup> EVENT</u>: Co-sponsoring invitation Sara Gold & Filomena Hengst to cosponsor workshop April 4th on the basics of protecting immigrant rights. (decision required).

Mr. Woods reported that the HRC is not co-sponsoring this event.

<u>LHRC BANNER</u>: Discussion and decision on LHRC Banner with Logo. JW with Eric Rounds.

Mr. Woods reported that he has met with Mr. Rounds who has some great ideas but they are in his head and not on paper for him to share with the members of Council. He will press the issue with Mr. Rounds and circulate with the members of the HRC.

EVENTS UPDATES Immigration Workshops, We Are One Lambertville, SHAD Fest.

Mr. Woods informed the members of the board and public present that he attended the Recreation Commission meeting and we received approval for the June 4<sup>th</sup> event to be co-sponsored by Fisherman's Mark. He will continue to meet with Fisherman's Mark to define the event and then disseminate information to committee so that the membership can help with the event. Ideas include:

FOOD: There will be food for sale by local restaurants/venders and Food Trucks. The public can also bring homemade prepared foods available for all to try for free with a disclaimer provided by the Hunterdon County Board of Health.

PORT O POTTIES: It is estimated that we will need 3 to 5 portopotties. It was suggested that we approach the LMUA to donate the portopotties.

DECORATIONS: Flags, Name Tags.

GAMES AND ACTIVITIES: Face painting, games, music and activities would be provided to the public.

ROAD CLOSURES: Mr. Woods will meet with Fisherman's Mark to define the event and detail what road closures are needed if any.

The HRC members may need to meet weekly to discuss the event. Mr. Woods will let everyone know at our next meeting. The goal is to prepare a flyer to circulate during Shad Festival to the members of the public.

#### GOALS:

Mr. Woods informed the members of the HRC present that the following ideas are his contribution on potential Goals for HRC 2017

EDUCATION: Continue our own education of immigration issues and rights.

ACTIVITIES/EVENTS: Investigation Sponsoring/co-sponsoring community activities re Immigrant Rights and Community Inclusion consistent with our Mission and Vision.

OTHER HRCS: Engage with other regional Human Rights groups to identify areas where we can work together to improve inclusiveness with different vulnerable groups. As this group continues to evolve, we will need to crystalize our goals and vision. We can work with local community groups with ties to this immigrant population to help us identify areas that need work.

Dan Seiter mentioned that at the High School the Board starts with a self-evaluation and it then evolves into a mission statement. He will obtain the generic information and share it with the HRC. It was noted that it may be too early for this HRC to take that path.
