- Team Leader Assignments due for today's meeting:

- IMMIGRANT TEAM LEAD – RONI TODD-MARINO
 - Definition of the focus community – including resident volumes. Population 500-550 latino community (15%) in City.
 - Human Rights issues/concerns/gaps for that focus community. Landlord violations, notaro's (false legal assistance), limited safety net services (no food stamps for undocumented population), health insurance due to change in possible/pending 'public charge' definition (when a person applies for naturalization if they have accessed services then they would not be considered for citizenship/strike against them), language barrier which includes lack of bilingual services in city hall, other city services, and access to immigration attorneys.
 - 2-3 solid ideas on how to support in 2019 (taste, touch, feel, real).
 - We Are One Lambertville picnic event (improving attendance/involvement of community).
 - Language Line, Transportation for affected groups. Mayor Fahl asked Beth Asaro to work with Cindy Ege to get bids on language translation lines for use by the city – evaluate costs and impact.

- IDs: Mayor Fahl asked Roni to consider and propose ways that the City of Lambertville can assist in promoting the Greater Hunterdon Community ID issued by Fisherman's Mark.
- Cost to support those 2-3 ideas – assessment underway
- Partners in community that would be needed, or optimal, to have to support your focus community ideas/projects. Roni is working on a local Fisherman's Mark residents board to include latino residents, and the goal is to have one of those members to join us as a consultant / resident partner to help us gain more traction in this community.
- MENTAL HEALTH TEAM LEAD – JOHN WOODS
 - Definition of the focus community – including overall affected/family/extended family/community resident volumes.
 - Assessment underway.
 - What are the generally accepted statistics nationally for the % of the population that have Mental Health/Substance Abuse issues?
 - What then are the statistics nationally for the extended family and community that is affected and involved with the directly affected community?
 - Human Rights issues/concerns/gaps for that focus community.
 - Develop a method to determine how people with Mental Health and Substance Abuse disorders are being treated within the community in various settings; i.e., housing, city government, merchants, residents.
 - 2-3 solid ideas on how to support in 2019 (taste, touch, feel, real)
 - Establish Lambertville as a STIGMA FREE ZONE. Involves bringing trainers/training to Lambertville. STIGMA FREE is a statewide group that has helped communities in NJ to achieve STIGMA FREE status. Target training community would be city employees, police, fire, rescue squad, greater OEM community, and interested City residents.
 - National Alliance on Mental Illness (NAMI) has a 'Smarts for Advocacy' hands-on advocacy training program that helps people living with mental illness and their friends and family transform their passion and lived experience into skillful grassroots advocacy. Alex Zeng has undergone this training and is willing to provide the training for free.
 - Cost to support those 2-3 ideas
 - Assessment underway.
 - Partners in community that would be needed, or optimal, to have to support your focus community ideas/projects.
 - Assessment underway.
