Mr. Cundy, the Board Engineer, was not present at the meeting but wanted to the Board members and the applicant to know that he was satisfied with the revised plans that were submitted and had no issues if the Board were to reinstate this application. However, he also noted that the applicant should be made aware that once the public hearing starts there may be additional information that he will request.

A brief discussion about postponing the Public Hearing until the September meeting ensued and it was agreed upon by the Board members that September would be a better month to hold the Public Hearing.
